- B. Mixed Use District Based on concerns regarding the number of potential residential units in the MU district, Jamie Keener prepared two sketches to show how the area might be developed with a mix of residential (single family and townhouses/row homes). Jamie Keener suggested that a Mixed Use overlay be considered while maintaining base zoning districts similar to what is on the existing zoning map. HRG will proceed with preparing a Mixed Use overlay and revising the zoning map as discussed.
- C. District Uses Several uses on the use table were revisited relative to whether they should be Permitted or Conditional use. Jamie Keener will research Manufactured Housing versus Mobile Home and present findings to the planning team.
- D. General Regulations Use this section for regulations that will cross all district boundaries, including lighting, access drives/driveways, etc. Uses/Specific Use Regulations will be a separate section.
- E. Parking Parking regulations were briefly discussed, including the minimum size of parking and the number of parking spaces required for specific uses. A ration shall be provided for each use identified in the use table. Retail uses such as the new Tractor Supply store should be considered in evaluating the ratio of spaces.
