The Howe Township Board of Supervisors met in regular session at the UPMC Pinnacle Health Community Room at 5:30 p.m. on July 18, 2019. Present: Chairman Dale Beaver, Vice Chairman Charles Burd, Supervisor Kathy Donahey, Secretary/Treasurer Nancy Cangioli, Zoning Officer Bob Hart, no residents were present

Chairman Beaver called the meeting to order with the Pledge of Allegiance. Secretary Cangioli called the roll. All Supervisors were present.

A motion was made to approve the minutes for June 6, June 20, June 26, 2019 as presented; Burd/Donahey. Motion carried.

ENGINEER

Chairman Beaver stated for the record that he will meeting with HRG on August 7th regarding the current Township Engineer Alex Greenly. There may potentially be a new Engineer assigned per HRG's recommendation.

MUNICIPAL AUTHORITY

Minutes from the June 17th and July 15th meetings have been submitted. Closing on the Penn Vest loan will be next Wednesday the 24th at 2:00 p.m.

JUNIATA SEWAGE COMMITTEE

Supervisor Burd reported there was a meeting June 26, 2019. He asked Bob Kratzer for a bill for services rendered to date. Bob will be submitting it after he finishes a project on the 27th. Regarding cabin affidavits-they are not exempt from the sewage laws, holding tanks are not permissible and cabins are not exempt from floodplain ordinances.

ROAD MASTER

Mountain Road-Pro Lawn was paid \$4,500 for the materials that were staged there. The end wall castings should be ready on August 1st by Monarch Products. The work should take about a week to complete. Tar and chipping was completed. Roadmaster Simpson needs to schedule the line painting. Gypsy Hollow wall repair-Ben Smith will be doing the work for \$19,175. It will take approximately 4 days to complete. He has submitted his certificate of insurance.

ZONING OFFICER

A temporary zoning permit was issued to Burger King pending corrections. A drive way permit was issued to Burger King. A zoning permit is pending for Rob Smith for a pole shed. An application has been received for Cathleen Campbell to demo a trailer.

PLANNING COMMISSION

There was no meeting in June. Burger King has submitted a subdivision plan for the meeting July 25th.
