Renewable Energy Resources: Solar Zoning Permit:

Building Mounted System – Residential, Non-Commercial or Agricultural Use - \$50

Ground Mounted System - Residential, Non-Commercial or Agricultural Use - \$100

Building Mounted System – Commercial or Industrial Use - \$150 for up to 25 panels. \$.10 per additional over 25 panels

Ground Mounted System-Commercial or Industrial Use - \$250 for up to 100 panels. \$.10 per additional panel over 100 panels

Zoning - \$600 + \$150 per ea. Continuation

- Stick-built homes & additions > 350 sq. ft., new construction
sq. ft. x 167.00 = est. cost x .0070 = permit fee
- * no plumbing or electric
sq. ft. x 128.00 = est. cost x .0070 = permit fee
- * electric, no plumbing or plumbing, no electric
sq. ft. x 143.00 = est. cost x .0070 = permit fee
- Modular home
sq. ft. x 157.00 = est. cost x .0070 = permit fee
- Attached garage
sq. ft. x 35.00 = est. cost x .0070 = permit fee
- Living space additions < 350 sq. ft.
5 insp.'s @ hourly rate = permit fee
- Detached accessory structure > 1000 sq. ft.
sq. ft. x 61.00 = est. cost x .0070 = permit fee
- Pole buildings > 1000 sq. ft.
 - sq. ft. x 35.00 = est. cost x .0070 = permit fee
- Manufactured home
 - Single-wide = 3 insp.'s @ hourly rate
 - Double-wide = 4 insp.'s @ hourly rate
- Deck/Porch
 - 2 insp.'s @ hourly rate
- Above-Ground Pool
 - 1 insp. @ hourly rate w/deck = 2 insp.'s @ hourly rate
- In-Ground Pool
 - 2 insp.'s @ hourly rate
- Residential Solar
Roof-mount = \$ 205.00 (flat rate)
Ground-mount = \$ 285.00 (flat rate + 1 insp.)
- Electrical Service Inspection
Residential - \$ 95.00
Commercial - \$ 125.00
