Present: Chairman Pat Ibaugh, Vice Chairman Charles Burd, Supervisor Jeff Rayson, Secretary Nancy Cangioli, Christine Campbell, Juanita Zeigler, Solicitor Dave Jones

Chairman Ibaugh called the meeting to order with the pledge of allegiance. Secretary Cangioli called the roll. All Supervisors were present.

A motion was made to approve the regular business meeting minutes of December 14, 2025, as presented; Burd/Rayson. Motion carried.
